2. This event includes, but not limited to, water sports, overnight camping, camp fires and other sports;
3. This event is held at the Negro bar in Folsom and physical harm could be caused by insects, animals and/or snakes.
4. I/we agree to attend to and monitor the activities of my FAMILY such that my/our FAMILY participates only in activities appropriate for them; and
5. I/we, for my FAMILY, knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of STM, or others, and assume full responsibility for my/our FAMILY's participation at this event; and
6. If I/we observe any hazards during my presence or participation, I/we will remove my FAMILY from the participation and bring said hazard to the attention of the nearest STM Board member immediately; and
7. I/we, for my/our FAMILY, on behalf of my/our heirs, assigns, personal representatives and next of kin, **HEREBY WAIVE, RELEASE, AND HOLD HARMLESS** STM, its Trustees, Board Members, volunteers, vendors, the facility providers and all other participants (collectively herein referred to as ORGANIZORS with respect to any and all claims for personal injury, disability, death, or loss or damage to person or property, even if arising from the negligence of the ORGANIZORS or otherwise; and
8. This release and waiver extends to all acts of negligence by the ORGANIZORS and is intended to be as broad and inclusive as permitted by the laws of the State of California.
9. **I/WE RELEASE AND AGREE TO HOLD HARMLESS AND INDEMNIFY THE "ORGANIZORS" FROM ANY AND ALL LIABILITIES INCIDENT TO MY/OUR FAMILY'S INVOLVEMENT OR PARTICIPATION IN THE PICNIC/CAMPING RELATED EVENTS, INCLUDING SUCH LOSS, LIABILITY, DAMAGE OR COST (INCLUDING ATTORNEY FEES) EVEN IF SUCH ACTION ARISES FROM THE NEGLIGENCE OF THE ORGANIZORS TO THE FULLEST EXTENT PERMITTED BY LAW. I/WE HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I/WE HAVE GIVEN UP SUBSTANTIAL RIGHTS FOR MY/OUR FAMILY BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT.**
